**Subject:** Information under RTI Act, 2005.

Please refer to your RTI application with registration number MEAKW/R/E/20/00017 dated 24-05-2020. Point-wise reply is as follows:

- (1). Exact details of who lost job are yet to be ascertained by the Kuwaiti authorities. Till 1<sup>st</sup> week of June around 10,000 Indians succeeded in returning to India through special flights.
- (2),(3),(4) The requisite information is not available with Embassy as the Business Visa, Personal Visit Visa and Pilgrimage visa are issued to the Indian Nationals by the Kuwaiti Government.
- (5) As on 09 June 2020, number of Indian nationals registered with the Mission for repatriation under the compelling reason - 'Pregnant/Elderly'- were more than 2400. Around 460 of these nationals were repatriated on flights under the Vande Bharat Mission and around 1980 were yet to be repatriated.
- (6). Necessary assistance for the migrants camps are being extended by the respective Employers/Companies, and in view of the COVID-19, the prescribed guidelines of Kuwaiti Ministry of Health are followed in these camps. However exact number of such workers were not provided by Kuwaiti Ministry of Social Justice and Labour.
- (7& 8) All the necessary assistance including food, accommodation, ticket etc are being provided by the Employers/Companies as per the Labour Laws of Kuwait. However, the Embassy has incurred the following expenditure from ICWF:


