Sir,

Please refer to your application seeking information under the RTI Act, 2005 vide Registration No. MEADO/R/E/20/00015 dated 06.05.2020.

2. Information sought by you is given below ad-seriatim.

(1) An amount equivalent to Indian Rupees 4,68,07,576/- was available in the Indian Community Welfare Fund (ICWF) as on 30.04.2020.

(2) An amount equivalent to Indian Rupees 4,51,24,726/- was available in the Indian Community Welfare Fund (ICWF) as on 31.03.2020.

(1) An amount equivalent to Indian Rupees 2,15,76,030/- was collected from 01.01.2019 to 31.12.2019 towards the ICWF by levying service charges on consular services.

(2) An amount equivalent to Indian Rupees 51,89,523/- was collected from 01.01.2020 to 30.04.2020 towards the ICWF by levying service charges on consular services.

(5) An amount equivalent to Indian Rupees 1,43,72,630/- was utilized in the year 2019 and an amount equivalent to Indian Rupees 26,40,447/- was utilized in the year 2020 (till April 30, 2020).

(6) An amount equivalent to Indian Rupees 2,47,141/- was spent from 01.01.2018 to 30.04.2020 towards legal assistance to Indian nationals.

(8 & 9) Local audit of the Embassy of India, Doha was last carried out in September, 2018 by a team from the Office of the Additional Deputy Comptroller & Auditor General (Central Expenditure, New Delhi. The team

also examined the management of the Indian Community Welfare Fund (ICWF). The final report may be sought from that office.
